## WATERCRAFT AND LAND CRAFT 2018 RENEWAL/REGISTRATION

PLEASE NOTE - Stickers may be purchased in the following ways:

- 1) **By mail** (send payment, completed form and copies of all proof needed for new items) or
- 2) **In person**, during listed office hours *only*

Please check your form for accuracy and contact our office for any corrections. Checks are to be made payable to Ponderosa Utilities, Inc. A \$15.00 service fee will be charged for returned checks.

**ANNUAL RENEWAL FEE:** \$8.00 per watercraft and land craft is due by **June 1<sup>st</sup>, 2018.**

A \$10.00 penalty fee will be charged for stickers not renewed by the due date.

**PROOF OF OWNERSHIP:** All new water and land craft items registered must include proof of ownership.

This includes a bill of sale or receipt, proof of insurance or State of Iowa registration number. *Failure to send the proper paperwork will delay your request.* Proof may also be mailed, faxed or emailed.

**NEW ITEMS:** The price to purchase stickers for newly acquired watercraft/land craft is \$10.00 per craft.

New stickers MUST be purchased for any new items – old stickers may not be used for new crafts.

**REPLACEMENT STICKERS:** The cost to purchase replacement '18 stickers *only* is \$8.00 per craft.

The cost to purchase replacement ID stickers w/'18's is \$10.00 per craft.

**RENTERS:** For liability reasons, renters are not allowed to have their own personal watercraft or land craft on Lake Ponderosa unless they are co-owned with the lot owner. Proof of ownership must be presented to our office.

STICKERS MUST BE VISIBLE AT ALL TIMES ON RECREATIONAL VEHICLES AND ABOVE THE WATERLINE ON WATERCRAFT. THEY MUST BE PERMANENTLY ADHERED TO BOTH SIDES.

STICKERS MUST BE PURCHASED FOR THE FOLLOWING ITEMS:

**Land craft** – All vehicles (other than licensed vehicles or lawn mowers) including dirt bikes, mopeds, mini bikes, ATV's (3&4) wheelers, golf carts, utility vehicles, rangers and any other motor vehicles. All land craft must have working headlights and tail lights if out after dark. State of Iowa law requires drivers to be 16 years of age.

**Watercraft** – All motorboats, sailboats, paddleboats, rowboats, trolling boats, pontoon boats, canoes, jet skis, wave runners, and wind surfers. State of Iowa law requires that persons age 12 to 18 provide the office with a watercraft safety certificate, and have it with them while using the watercraft.
